**ART.1: ORGANIZATION**

A.S.D. ISM GRADISCA AND A.S.D. TORNEI ED EVENTI INTERNAZIONALI ORGANIZES AN INTERNATIONAL TOURNAMENT ENTITLED "DELLE NAZIONI". THE TOURNAMENT WILL BE PLAYED FROM APRIL 27<sup>TH</sup> APRIL TO MAY 03<sup>RD</sup> 2019 IN ITALY REGION FRIULI VENEZIA GIULIA, VENETO AND IN SLOVENIA

**ART.2: CATEGORY OF PARTICIPATION AND AGE LIMITS**

THE TOURNAMENT IS RESERVED TO TEAMS U17 REGULARLY ENROLLED WITH HER OWN SOCIETY AND FEDERATION FOR THE SEASON IN PROGRESS AND THEY HAD BEEN BORN FROM 01/01/2002 TO 27/04/2005.

**ART.3: LOANS**

NOT ADMITTED.

**ART.4: FOOTBALL PLAYERS LIST**

A LIST OF PLAYERS ELIGIBLE TO PARTICIPATE SHALL BE DELIVERED TO THE ORGANIZER COMMITTEE BEFORE THE START OF THE TOURNAMENT. LISTS MUST INCLUDE A MAXIMUM OF 20 PLAYERS.

ONCE THE LISTS HAVE BEEN DELIVERED TO THE ORGANIZER COMMITTEE, THIS CAN NOT BE CHANGED.

THE LIST OF PLAYERS FOR TEAM, THAT SHALL BE PRODUCED FOR THE REFEREE, IS LIMITED TO 20 PLAYERS.

**ART.5: SUBSTITUTION**

SUBSTITUTION ARE ALLOWED IN NUMBER OF 7 INDEPENDENTLY FROM THE ROLE AT ANY TIME DURING THE MATCH.

**ART.6: PARTICIPATING TEAMS**

THE TEAMS THAT WILL ATTEND THE TOURNAMENT ARE:

**ART.7 TOURNAMENT FORMULA**

8 NATIONAL TEAMS WILL BE ADMITTED AND DIVIDED INTO 2 GROUPS OF 4 TEAMS EACH. AFTER THE GROUP STAGE THE TWO FIRST TEAMS WILL PLAY THE FINAL FOR 1<sup>ST</sup> - 2<sup>ND</sup> PLACE; THE TWO SECOND TEAMS WILL PLAY THE FINAL FOR 3<sup>RD</sup> - 4<sup>TH</sup> PLACE, THE TWO THIRD TEAMS WILL PLAY THE FINAL FOR 5<sup>TH</sup> – 6<sup>TH</sup> PLACE AND THE TWO FOURTH TEAMS WILL PLAY THE FINAL FOR 7<sup>TH</sup> – 8<sup>TH</sup> PLACE.

**ART. 8 RANKING**

THE RANKING WILL BE DRAWN UP ACCORDINGLY THE FOLLOWING CRITERIA:

3 POINTS FOR WIN - 1 POINT FOR DRAW - 0 POINTS FOR DEFEAT

IN CASE OF EQUAL POINTS APPLY THE CRITERIA IN ORDER LISTED:

1. OUTCOME OF DIRECT MATCHES
2. DIFFERENCE GOALS SCORED IN DIRECT MATCH BETWEEN THE TEAMS TO EQUALITY OF POINTS

3. DIFFERENCE GOALS SCORED ON TOTAL OF MATCHES PLAYED IN ROUND
4. HIGHEST NUMBER OF GOALS SCORED ON TOTAL OF MATCHES PLAYED IN ROUND
5. DISCIPLINE RANKING
6. DRAWING

#### **ART.9 HALVES OF GAMES**

ALL MATCHES OF GROUP PHASE WILL BE PLAYED IN 2 (TWO) HALVES OF 35 MINUTES EACH. THE FINAL MATCH FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE WILL BE PLAYED IN 2 (TWO) HALVES OF 40 MINUTES EACH.

MATCHES ARE PLAYED 11 VS 11 REGULAR FOOTBALL FIELD WITH REGULAR GOALS AND BALLS N. 5.

#### **ART.10 PENALTY**

AFTER GROUP STAGE, IN CASE OF DRAW (EXCEPT FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE FINAL) AFTER END OF REGULAR TIME, PENALTIES WILL BE KICKED.

PENALTIES WILL BE MADE ACCORDINGLY WITH THE CRITERIA FIXED BY ARTICLE 14 OF THE RULES OF THE GAME AND OF THE OFFICIALS DECISIONS.

#### **ART.11. EXTRA TIME (ONLY FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE FINAL)**

ONLY FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE FINAL, IN CASE OF DRAW AFTER END OF REGULAR TIME, TWO EXTRA TIMES OF TEN MINUTES EACH WILL BE PLAYED. IN CASE OF DRAW AFTER THE END OF EXTRA TIMES, PENALTIES WILL BE KICKED AS PER ARTICLE 10.

#### **ART.12 REFEREES**

THE MATCHES PLAYED IN ITALY WILL BE DIRECTED BY REFEREES F.I.G.C. / A.I.A. AND THE MATCHES PLAYED IN SLOVENIA WILL BE DIRECTED BY REFEREES FROM SLOVENIAN FEDERATION NZS.

#### **ART. 13 TOURNAMENT COMMITTEE**

THE TOURNAMENT COMMITTEE WILL BE IN CHARGE OF EVERY QUARELL, PROTEST, COMPLAINT AND ANY OTHER UNFORESEEN CIRCUMSTANCE. MEMBERS OF THE COMMITTEE ARE:

WHEN NECESSARY, THE COMMITTEE WILL SEND A REPORT TO THE NATIONAL FEDARATION.

THE COMMITTEE WILL NOT ACCEPT ANY PROTEST OR COMPLAINT ABOUT REFEREE DECISIONS.

MISCONDUCT OF PLAYERS WILL BE SIGNALLED TO THEIR OWN FEDERATION, WHICH WILL TAKE THE MORE APPROPRIATE FINAL DECISION.

MISCONDUCT OF ANY OF THE MEMBERS OF THE PARTEICIPANTING DELEGATIONS WILL BE REPORTED IN WRITTEN BY THE TOURNAMENT COMMITTEE TO THE NATIONAL AND INTERNATIONAL FEDERATION, WHICH WILL TAKE THE MORE APPROPRIATE FINAL DECISION.

#### **ART.14 DISCIPLINE OF THE TOURNAMENT**

THE TOURNAMENT REGULATION WILL BE GRANTED BY THE REGULAR/SUPPLY ARBITRATOR OF THE ITALIAN GORIZIA FIGC COMMITTEE.

#### **ART.15 IMMEDIACY OF SANCTIONS**

THE IMMEDIACY OF SANCTIONS IS PROVIDED BY REGULATIONS AS FOLLOWS: A PLAYER SENT OFF DURING A GAME WILL NOT PARTECIPATE TO THE FOLLOWING MATCH, EXCEPT IN CASE OF MORE SEVERE SANCTIONS IMPOSED BY THE SPORT JUDGE; A PLAYER ADMONISHED TWICE DURING THE TOURNAMENT WILL BE DISQUALIFIED FOR A MATCH AFTER A SANCTION OF THE SPORT JUDGE.

#### **ART.16 COMPLAINT**

THE COMPLAINT HAVE TO BE FORWARD TO THE REFEREE WITHIN 30 MINUTES AFTER THE END OF THE MATCH AND AFTER THE PAYMENT OF FEE € 52, 00. A COPY OF THE CLAIM HAS TO BE FORWARD TO THE COUNTERPART WITHIN 30

MINUTES AFTER THE END OF THE MATCH. THE COMMITTEE WILL NOT ACCEPT PROTESTS OR COMPLAINTS RELATING TO DECISIONS TAKEN BY THE REFEREE.

**ART. 17 INSURANCE**

EVERY PARTICIPANT FEDERATION HAS TO PROVIDE HIS PLAYERS THE INSURANCE COVER.  
THE TOURNAMENT ORGANIZATION IS RESPONSIBLE OF THE REGULARITY OF THE INSURANCE COVER.

**ART.18 I.F.A.B.**

THE MATCHES ARE PLAYED WITH THE RULES OF THE INTERNATIONAL FOOTBALL ASSOCIATIONS BOARD (IFAB) OF THE CURRENT EDITION.

**ART.19 GENERAL RULES**

BEFORE THE START OF THE TOURNAMENT, THE ORGANIZATION COMMITTEE WILL SEND TO ALL PARTICIPANT TEAMS THE REGULATION ONCE AUTHORIZED  
AS REGARDS ANYTHING NOT DIRECTLY PROVIDED BY THIS REGULATIONS, NORMS OF FEDERAL REGULATIONS ARE VALID. THE TOURNAMENT WILL BE DIRECTED IN ACCORDANCE WITH LAST EDITION OF I.F.A.B. RULES.

**A) GREETING**

THE DIRECTORS AND OPERATORS OF THE FEDERATIONS WILL ENSURE THAT AT THE BEGINNING AND AT THE END OF EACH GAME, THE PLAYERS GREET THE SPECTATORS AND GREAT EACH OTHER BY SHACKING HANDS.

**B) WAITING TIME**

THE TEAMS WILL HAVE TO BE ON THE PITCH WEARING THE UNIFORM WITHIN 15 MINUTES ON THE FIXED TIME.

**C) INTERRUPTION OF GAME**

DURING THE GROUP PHASE, IN CASE OF INTERRUPTION OF THE MATCH DUE TO IMPRACTICABILITY OF THE PITCH, THE RESULT SINCE THEN WILL BE VALID. DURING THE FINAL PHASE, IF THE SCORE IS TIE, THERE WILL BE A DRAW IN FRONT OF REFEREE AND CAPTAINS OF BOTH TEAMS.

**D) FAILING OF A GAME'S START**

IF THE GAME DOESN'T START DUE TO A QUESTION OF MAJEURE FORCE, AND IT'S NOT DEPENDING BY THE TEAMS, THERE WILL BE A DRAW IN FRONT OF REFEREE AND CAPTAINS OF BOTH TEAMS AND TO THE WINNER WILL BE ASSIGNED A SCORE OF 3-0.

**E) IDENTITY DOCUMENT**

TOGETHER TO THE PLAYERS LIST IN ARTICLE 4, BEFORE EACH MATCH THE TEAMS MUST PRESENT TO THE REFEREE THE IDENTITY DOCUMENT OF ALL PLAYERS AND ALL STAFF THAT WILL HAVE ACCESS TO THE PITCH.
