1. Categories of data			
The CSEN Affiliate collects personal data within the limits of the purposes and methods defined in this information notice. The Data subject to processing are: - personal and contact data;			
- data relating to health in the context of the COVID-19 emergency situation, with particular reference to those relating to the measurement of body temperature; information on close			
auta relating to relatin in the context of the comp-15 emergency situation, with particular relating to the measurement of body temperature, information on crose			

contacts at high risk of exposure, in the last 14 days, with subjects suspected of or tested positive for COVID-19; information on the origin, in the last 14 days, from areas at risk according to WHO indications; information relating to isolation or quarantine. The provision of these data is necessary to be able to participate in the activities.

Purpose and legal basis of processing 2.

Health-related data will be processed exclusively for the purpose of prevention of COVID-19 infection: with reference to data relating to the weekly anamnesis, with particular reference to symptoms, such data will be processed subject to the consent of the person concerned.

Health data in the context of the COVID-19 emergency situation will be processed exclusively for the purpose of preventing COVID-19 infection, in execution of the Anti-Contagium Security Protocol adopted pursuant to Article 1, no. 7, letter d) of the Prime Ministerial Decree of 11 March 2020. The legal basis of the processing is, therefore, to be found in the implementation of the anti-contagious security protocols pursuant to Article 1, no. 7, letter d) of the Prime Ministerial Decree of 11 March 2020. Storage of personal data 3.

The data collected and related to health will be processed for the time strictly necessary to pursue the aforementioned purpose of preventing contagion from COVID-19 and stored no later than the end of the state of emergency, currently set at 31 July 2021.

## 4. Disclosure of recipients

Personal data will not be disclosed or communicated to third parties, except in accordance with specific regulatory provisions (e.g. in the event of a request by the Health Authority to reconstruct the chain of any close contacts of a person who has tested positive for COVID-19).

Rights of the data subject 5

We inform you that, in accordance with the regulations in force, you have the following rights request and obtain information about the existence of your own data in the possession of the Data Controller and access to such data; for data subject to processing by automated systems, request the communication of your own data and/or the transfer to another data controller; request and obtain the modification and/or correction of your personal data if you believe that they are inaccurate or incomplete; request and o btain the cancellation - and/or limitation of the processing - of your personal data if they are not necessary - or no longer necessary - for the above purposes, then after the storage period indicated in the following paragraph.
