



## 21<sup>st</sup> TORNEO DELLE NAZIONI APRIL 25<sup>th</sup> – MAY 1<sup>st</sup> 2025



### **ART. 1 – ORGANIZATION**

A.S.D. ISM GRADISCA IN COOPERATION WITH A.S.D. TORNEI ED EVENTI INTERNAZIONALI ORGANIZE AND INDICT THE 21<sup>st</sup> EDITION OF THE INTERNATIONAL TOURNAMENT CALLED "TORNEO DELLE NAZIONI", THAT WILL TAKE PLACE FROM APRIL 25<sup>th</sup> TO MAY 1<sup>st</sup> 2025 IN GRADISCA D'ISONZO, IN ITALY REGION FRIULI VENEZIA GIULIA, IN SLOVENIA AND IN AUSTRIA.

### **ART. 2 – AGE LIMITS**

THE TOURNAMENT IS RESERVED TO PLAYERS CATEGORY U15 REGULARLY ENROLLED WITH HIS OWN SOCIETY AND FEDERATION BELONG FOR THE SEASON IN PROGRESS HAD BEEN BORN FROM 01/01/2010 TO 31/12/2011. IT'S POSSIBLE TO USE UP TO 5 PLAYERS BORN IN 2012 WHO HAVE REACHED THE AGE OF 12 BY THE START OF THE TOURNAMENT.

### **ART. 4 – PLAYERS LIST**

PARTICIPATING FEDERATIONS MUST SUBMIT TO THE TOURNAMENT ORGANIZATION, BEFORE THE BEGINNING OF THE TOURNAMENT, THE LIST OF PLAYERS THEY INTEND TO USE, UP TO A MAXIMUM OF 22. AFTER SUBMISSION, NO CHANGES CAN BE MADE TO THESE LISTS. IN THE EVENT OF AN INJURY PREVENTING A GOALKEEPER FROM CONTINUING THE TOURNAMENT, THE INJURED GOALKEEPER MAY BE REPLACED UPON PRIOR NOTIFICATION. THE LIST TO BE PRESENTED TO THE REFEREE BEFORE THE MATCH WILL INCLUDE UP TO A MAXIMUM OF 22 PLAYERS.

### **ART. 5 – SOBSTITUTIONS**

SUBSTITUTION ARE ALLOWED IN NUMBER OF 7 INDIPENDENTLY FROM THE ROLE AT ANY TIME DURING THE MATCH. MATCH MAY BE INTERRUPTED A MAXIMUM OF 3 TIMES FOR SOBSTITUTIONS.

### **ART. 6 – PARTICIPANT TEAMS**

### **ART. 7 – TOURNAMENT FORMULA AND RANKING**

12 NATIONAL TEAMS WILL BE ADMITTED AND DIVIDED INTO 4 GROUPS OF 3 TEAMS EACH. AFTER THE END OF GROUP STAGE, THE FOUR FIRST TEAMS WILL QUALIFY FOR THE SEMIFINALS AND FINALS FOR 1ST, 2ND, 3RD AND 4TH PLACE; THE FOUR SECOND TEAMS WILL QUALIFY FOR THE SEMIFINALS AND FINALS 5TH, 6TH, 7TH, 8TH PLACE; THE FOUR THIRD TEAMS WILL QUALIFY FOR THE SEMIFINALS AND FINALS 9TH, 10TH, 11TH, 12TH PLACE.

### **ART. 8 – RANKING**

THE RANKING WILL BE DRAWN UP IN LIGHT OF THE FOLLOWING CRITERIA:

3 POINTS FOR WIN - 1 POINT FOR DRAW - 0 POINTS FOR DEFEAT

IN CASE OF EQUAL POINTS APPLY THE CRITERIA IN ORDER LISTED:

1. OUTCOME OF DIRECT MATCHES
2. DIFFERENCE GOALS SCORED IN DIRECT MATCH BETWEEN THE TEAMS TO EQUALITY OF POINTS
3. DIFFERENCE GOALS SCORED ON TOTAL OF MATCHES PLAYED IN ALL GROUP MATCHES

4. HIGHEST NUMBER OF GOALS SCORED ON TOTAL OF MATCHES PLAYED IN ALL GROUP MATCHES
5. DISCIPLINE RANKING
6. DRAWING

**ART. 9 – MATCHES TIME**

DURATION: TWO EQUAL PERIODS OF 35 MINUTES.

MATCHES ARE PLAYED 11> 11 REGULAR FOOTBALL FIELD WITH REGULAR GOALS AND BALLS N. 5.

**ART. 10 – PENALTIES**

AFTER GROUP STAGE, IN CASE OF DRAW (EXCEPT FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE FINAL) AFTER END OF REGULAR TIME, PENALTIES WILL BE KICKED.

PENALTIES WILL BE MADE ACCORDINGLY WITH THE CRITERIA FIXED BY ARTICLE 10.3 OF THE RULES OF THE GAME AND OF THE OFFICIALS DECISIONS

**ART. 11 – EXTRA TIME**

ONLY FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE FINAL, IN CASE OF DRAW AFTER END OF REGULAR TIME, TWO EXTRA TIMES OF TEN MINUTES EACH WILL BE PLAYED. IN CASE OF DRAW ALSO AFTER END OF EXTRA TIMES, PENALTIES WILL BE KICKED AS PER ARTICLE 10.

**ART. 12 – REFEREES**

THE MATCHES PLAYED IN ITALY WILL BE DIRECTED BY REFEREES F.I.G.C. / A.I.A., THE MATCHES PLAYED IN SLOVENIA WILL BE DIRECTED BY REFEREES OF NZS SLOVENIAN FEDERATION AND THE MATCHES PLAYED IN AUSTRIA WILL BE DIRECTED BY REFEREES OF OFB AUSTRIAN FEDERATION

**ART. 13 – TOURNAMENT COMMITTEE**

A TOURNAMENT COMMITTEE WILL BE ESTABLISHED AND WILL BE RESPONSIBLE FOR ANY DISPUTE, PROTEST, GRIEVANCE OR UNFORESEEN CIRCUMSTANCE. THE COMMITTEE WILL BE COMPOSED OF THE FOLLOWING PERSONS:

THE COMMITTEE WILL NOT ACCEPT PROTESTS OR COMPLAINTS ABOUT DECISIONS TAKEN BY THE REFEREES.

THE COMMITTEE WILL REPORT TO ITS NATIONAL OR INTERNATIONAL FEDERATION ANY PLAYER OR MEMBER OF PARTICIPATING DELEGATIONS FOUND GUILTY OF UNSPORTING CONDUCT DURING THE TOURNAMENT.

**ART. 14 – TOURNAMENT DISCIPLINE**

THE DISCIPLINE OF THE TOURNAMENT IS ENTRUSTED TO THE SPORTS JUDGE OF THE PROVINCIAL DELEGATION F.I.G.C. OF GORIZIA.

**ART. 15 – AUTOMATISM OF SANCTIONS**

THE AUTOMATISM OF SANCTIONS IS PROVIDED BY REGULATIONS AS FOLLOWS: A PLAYER SENT OFF DURING A GAME WILL NOT PARTECIPATE TO THE FOLLOWING MATCH, EXCEPT IN CASE OF MORE SEVERE SANCTIONS IMPOSED BY THE SPORT JUDGE; A PLAYER ADMONISHED TWICE DURING THE TOURNAMENT WILL BE DISQUALIFIED FOR A MATCH AFTER A SANCTION OF THE SPORT JUDGE.

AFTER GROUP PHASE, THE YELLOW CARDS WILL BE ERASED. A PLAYER THAT WILL RECEIVE THE SECOND YELLOW CARD DURING THE SECOND GROUP PHASE MATCH, WILL BE DISQUALIFIED FOR THE SEMIFINAL (3<sup>rd</sup> MATCH) AFTER A SANCTION OF THE SPORT JUDGE.

**ART. 16 – COMPLAINTS**

ANY COMPLAINTS MUST BE SUBMITTED BY HAND TO THE REFEREE WITHIN 30 (THIRTY) MINUTES FROM THE END OF THE MATCH TO WHICH THEY REFER, TOGETHER WITH THE COMPLAINT FEE OF 52 EUROS; A COPY OF THE COMPLAINT MUST BE DELIVERED TO THE OTHER PARTY WITHIN 30 MINUTES.

**ART. 17 – INSURANCE**

IT IS THE RESPONSIBILITY OF EACH PARTICIPATING FEDERATION TO ENSURE THAT ITS PLAYERS ARE COVERED BY INSURANCE.

THE TOURNAMENT ORGANIZATION IS RESPONSIBLE FOR THE REGULARITY OF THE INSURANCE COVERAGE.

**ART. 18 – I.F.A.B.**

MATCHES WILL BE PLAYED ACCORDING TO THE RULES OF THE INTERNATIONAL FOOTBALL ASSOCIATION BOARD (IFAB) CURRENT EDITION.

**ART. 19 – GENERAL RULES**

FOR ANYTHING NOT PROVIDED FOR IN THESE REGULATIONS, THE PROVISIONS OF THE FEDERAL REGULATIONS APPLY, INSOFAR AS THEY ARE COMPATIBLE, AND THOSE REPORTED IN THE OFFICIAL COMMUNIQUÉ NO. 1 OF THE YOUTH AND SCHOOL SECTOR FOR THE CURRENT SEASON.

**A) GREETINGS**

THE MANAGERS AND COACHES OF THE FEDERATIONS PARTICIPATING IN THE TOURNAMENT MUST ENSURE THAT, BOTH AT THE BEGINNING AND AT THE END OF EACH GAME, THE PARTICIPANTS GREET THE PUBLIC AND GREET EACH OTHER.

**B) WAITING TIME**

TEAMS MUST REPORT TO THE FIELD IN GAME UNIFORM WITHIN 15 MINUTES OF THE SCHEDULED TIME.

**C) IDENTITY DOCUMENTS**

TOGETHER WITH THE LIST OF PLAYERS AS PER ARTICLE 4, BEFORE THE BEGINNING OF EACH MATCH THE TEAMS WILL HAVE TO PRESENT TO THE REFEREE THE IDENTITY DOCUMENTS OF PLAYERS AND STAFF WHO WILL HAVE ACCESS TO THE MATCH FIELD.
